Advanced techniques in one on one skills, reading and using screens, getting open without the basketball, ball-handling/passing routines, shooting fundamentals & post up techniques.

Camp Director: Chris Mennig, STM Head Girls Basketball Coach and varsity players. Coach Mennig came to STM after coaching at the college level for 11 years. He has lead the STM girls program to three league championships & two state regional championship in just four years. A former asst coach at the Univ. of Illinois & Illinois State, Mennig is a member of the McDonald’s All-American committee & a national evaluator for Nike’s Blue Star Basketball.
